

Limited Warranty – CANON MEDICAL COMPONENTS U.S.A., INC. VSD Cameras

CANON MEDICAL COMPONENTS U.S.A., INC. - Video Sensing Devices ("VSD") makes the following limited warranties with regard to this Camera ("Product"). These limited warranties extend to the Original End-User only ("You" or "Your", as used herein).

Covered Components. The following components are covered by this warranty - single piece camera systems, camera heads, camera control units (CCU), and related accessories including, interface cables connecting camera head to CCU, mounting adapter plates, CCTV lens supplied by VSD and AC power adapters.

Components not covered through this warranty – any accessories or modifications added by End-User, cables for video output, USB and RS232 control, chip-on-tip video cameras, video borescopes, prism block configurations, board level video camera modules, customized video camera systems and components

One (1) Year Limited Warranty of Labor and Parts

VSD warrants that this Product will perform in accordance with specifications for a period of one (1) year from the date of purchase by the Original End-User. During this one (1) year period, VSD will repair or replace the Product, if it does not perform as warranted. In order to take advantage of this Limited Warranty, You must: (a) deliver the Product to a VSD Authorized Service Provider ("ASP"); and (b) pay all transportation and insurance charges for shipment of the Product to the ASP. VSD reserves the right to substitute factory refurbished parts in place of those in need of repair.

Instruction Manual (Owner's Manual):

You should read the Instruction Manual (Owner's Manual) thoroughly before operating this Product. Before seeking warranty service, you should check the troubleshooting guide in the Instruction Manual (Owner's Manual) and follow the instructions to correct the problem.

Warranty service under this Limited Warranty is subject to the following conditions and procedures:

1. All warranty servicing of the Product must be made by an ASP (Authorized Service Provider).
2. You must notify an ASP within thirty (30) days after You discover that the Product does not perform in accordance with specifications during the Limited Warranty period.
3. You must securely pack the Product in its original carton using the original packing material.
4. You must insert the original carton containing the Product, a letter explaining the problem AND a copy of the bill of sale or proof of purchase into another carton with additional packing material before shipping the Product to an ASP.
5. You must prepay all transportation and insurance costs.
